Due to insufficient funds in the current account (no transfer had been made from the deposit account), the bank decided not to pay the cheque. It was agreed to reissue the cheque, also £4 costs.

OTHER MATTERS

A complaint was discussed regarding dog fouling. It was agreed to offer dog waste bags to the public and ask the County Council to consider cleaning the roads / pavements.

A new traffic viewing mirror is required on the road near Madoc Farm / Refail Newydd - the Clerk will bring the matter to the attention of the County Council. The bus shelters need to be painted. It was decided to ask the youth club to volunteer to do the work when the weather improves.
